Building works

As you are probably aware the building work has started! We are currently in the process of having a part of the school reroofed and also having a new room built to support our children with SEN. Although we are slightly "upside down" there are still the main entrances to get into school and we hope it will cause minimum disruption. Please bear with us as we are aware things are a little different, particularly at the front of the school.

Free Meal Vouchers

We would like to inform you that, due to a reduction in funding from the Household Support Fund (HSF) 2025/26, we are unfortunately no longer able to provide Free School Meal vouchers during school holiday periods.

We understand that this change may have a considerable impact on many households, especially during times when children are not in school and access to meals may be more limited. This decision has not been made lightly, and we recognise the challenges it may present for families who have previously relied on this support.

We encourage families to check with local community organisations and food support services, which may be able to offer help. Additionally there is further information regarding support available within Nottingham on our webpage -

Penalty Notice Fines for School Attendance Holidays in Term Time

Per Parent, Per Child

Penalty Notice fines will now be issued to each parent, for each child that was absent. For example: 3 siblings absent for term time leave, would result in each parent receiving 3 separate fines.

First Offence

The first time a Penalty Notice is issued for Term Time leave of irregular attendance the amount will be:

£160 per parent, per child if paid within 28 days

Reduced to £80 per parent, per child if paid within 21 days

Second Offence (Within 3 years)

The second time a Penalty Notice is issued for Term Time leave or irregular attendance the amount will be £160 per parent, per child paid within 28 days

Third Offence and Any Further Offences (within 3 years)

The third time an offence is committed for Term Time leave or irregular attendance a Penalty Notice will not be issued, and the case will be presented straight to the Magistrates' Court. Magistrates' fines can be up to £2500 per parent, per child

Cases found guilty in Magistrates' Court can show on the parents future DBS certificate, due to a 'failure to safeguard a child's education'.

Please remember to check term dates before booking holidays.



Procedures for dismissal at the end of the school day..

Please can you make sure that you contact school before 3pm if someone different is collecting your child. We will not allow children to leave school without the appropriate adult.

If you would like to speak to staff at the end of the school day please can I kindly ask that you wait until the children have been dismissed. The class teacher will speak to you but it is important that the class teacher dismisses all the children before doing this. Thank you for your

A Message From Councillor Linda Woodings

Let's Keep Our Children Safe Outside School

Very sadly, over the last school year, we had three children injured after being knocked down by cars outside different Nottingham schools. Not by passers by, but by other parents who had dropped off their own children and were rushing to get away.

With the new year of students we are asking all parents and carers to...

BE TIMELY - Can people try to get to school in good time to be able to park away from the school gates, especially the zig-zag lines, and walk their children up to the school gates? This keeps the area clear from hazards, giving better visibility to everyone.

BE CONSIDERATE - Can parents/carers please park considerately; not blocking the pavement or residents driveways, and can they turn off their engines whilst waiting?

BE PATIENT - Can drivers be careful and patient as they drive away? This is when accidents have previously happened.

Rise Park Primary & Nursery School Agreement for the acceptable use of the internet, e-mails and computers

At Rise Park Primary & Nursery School, we understand the importance and benefits of using computers to help with children's learning and personal development. However, we also recognise that safeguards need to be put in place to ensure children are kept safe at all times.

Please could parents/carers read and discuss this policy with their child and then sign one copy and return to the school office, and keep the other one for reference.

- I will only use digital devices and digital technology in school for school purposes.
- I will only use my school e-mail address when e-mailing.
- I will only open e-mail attachments from people I know, or who my teacher has approved.
- I will not tell other people my password or allow them to access my account.
- I will only open my own files and never access other people's work.
- I will make sure that all digital contact with other children and adults is responsible, polite and sensible as it would be if I were talking to the person face-to-face.
- I will not send anyone material using a digital device that could be considered to be threatening, bullying, offensive or illegal.
- I will not deliberately look for, save or send anything that could be unpleasant or nasty. If I accidentally find anything like this I will tell my teacher immediately.
- I will not give out my own personal details such as my name, phone number or home address to anyone online. I will not share the details of anyone I live with.
- I will not arrange to meet someone who has contacted me on a computer or digital device, and I will tell a grown-up if someone asks me to meet them.
- I will be responsible for my behaviour when using digital devices and digital technology because I know that these rules are to keep me safe.
- I will support the school approach to online safety and not deliberately upload or add any images, video, sounds or text that could upset any member of the school community.
- I know that **my use of digital devices in school can be checked** and that my parent or carer will be contacted if a member of school staff is concerned about my e-safety.
- Further to this, I understand that children under the age of 13 years old should not have access to a social media account on any social media platform, as the minimum age requirements for having an account on social media is 13 years old and above.
- I understand that if I choose to use social media, or in the case of parents, choose to let my children use social media, there are online safety risks which accompany this use, including online bullying and e-safety concerns. Children at Rise Park will never have access to any kind of social media whilst on school premises, and should not reference the school or staff online if they have access to social media as this could pose a safequarding risk.

 Provide a learning environment that is safe and caring. Ensure equal opportunities, support and guidance to enable each pupil to attain their full potential. Report regularly on each pupil's progress through meetings and reports. Regularly inform and update parents on all aspects of school life, including newsletters, the web site, and the ROAs. Encourage and celebrate pupils who show the <i>Rise Park values</i>. Monitor and record progress, attendance and behaviour in accordance with the school's policies. Inform parents/ carers of any concerns that may arise and be available, by prior agreement, to discuss any issues. 	 Make sure my child arrives at school on time, with the correct equipment and in the correct school uniform. Make sure my child attends school regularly, and notify the school promptly with reasons for lateness/ absence, (before 9:00 each day). Make arrangements for my child's safe return home, at the appropriate time. Support my child's learning, including the completion of any homework set. Inform the school directly regarding concerns which may affect my child's work or behaviour, through the correct channels. Attend parents' evenings as well as other meetings regarding my child's welfare/ progress. Keep an open dialogue with staff and be respectful at all times. Not post defamatory comments regarding the school/ staff on social media, including Facebook and Whatsapp. 	 Show the Rise Parker values of: trust, perseverance, hard work, determination, challenging myself, and being friendly, supportive and helpful. Come to school regularly and on time with the correct equipment, and in the correct school uniform. Follow school and class rules. Consistently give my best in all aspects of school life. Complete set tasks, both at home and school to the best of my ability. Treat others as I'd like to be treated myself both in school and on social media if I am allowed to use it.
